The company plans to develop a 36,000 m² tri-temperature facility on a 63,000 m² plot, including over 20,000 m² of temperature-controlled space (both positive and negative cold storage). This facility will position Ontime as a key player in cold chain logistics in Andalusia.

This strategic decision reflects Ontime's desire to operate a comprehensive, multimodal, and decarbonized logistics hub that meets today's industry demands. The site's exceptional connectivity—by road, rail, sea, and air—was a decisive factor in the company's choice

Puerto Seco de Antequera: A Future-Oriented Hub

Located at a major logistics crossroads in southern Europe, Puerto Seco de Antequera spans over 330 hectares. It is one of the most ambitious multimodal hubs in Southern Europe, offering direct access to both Mediterranean and Atlantic rail corridors as well as Spain's primary highway network.

The project is part of a sustainable and innovative development vision, supported by a public-private partnership initiated in 2009 and integrated into the Andalusian Logistics Network (Red Logística de Andalucía). It provides an optimal environment for companies seeking high-performance logistics, energy efficiency, and operational resilience.

Through this first project on the Iberian Peninsula, GROUPE IDEC reaffirms its commitment to investing in regions with strong strategic potential for the future of European logistics.
